	into 3 (three) installments of R\$1.190,67 (one thousand one hundred and ninety reais and sixty seven cents). Said	d amount
	will be charged jointly with the school tuition and regular monthly expenses incurred by the above mentioned stu	udent, for
	the purpose of 1 (one) trip within Brazil, with said travel part of the teaching plan. The amount stated herein incl	ludes the
	traveling expenses - food, lodging and shuttle services. - Should the legal guardian of the above mentioned minor decide to transfer the student from the school, the installments not yet due shall become due ahead of schedule and must be paid at the time of check out, in the event the trip has already taken place.
- 3. If the student decide to abandon the study after the study started, the legal guardian of the above-mentioned minor is responsible for all expenses generated by this situation and no reimbursement or restitution possibility.
- 4. All cancelations should be stated by the legal guardian of the above mentioned minor in writing reporting why the student will not take part on the trip, respecting the following:
- Cancelation requests from Nov. 12th to Jan 3rd, 2017, there will be a 10% charge of the total amount of the trip
- Cancelation requests from Jan 4th to Feb 14th, 2017, there will be a 50% charge of the total amount of the trip
- Cancelation requests from Feb 15th, 2017 until the day of the trip, the total amount of the trip will be charged
- 5. The legal guardian of the above mentioned minor shall be held liable for the obligation assumed herein, even in the event of force majeure. In the event the School receives any return amounts from the travel agency/tour operator related to the cancellation of the student who does not participate in the trip, said amount will be returned to the legal guardian upon receipt.
- 6. If any of the installments described in the first clause of this liability commitment are paid outside the respective due dates, the same shall accrue the same interest for arrears on the past-due installments as are paid on school tuition.
- 7. In the event of judicial or extrajudicial collection, in addition to the amounts past due, with their respective interest for arrears, the legal guardian of the above mentioned minor shall reimburse the School for procedural expenses and costs, as well as legal fees that the school may expend in order to ensure its rights.
- 8. The legal representative of the above mentioned minor does agree with the selection of the central or district Court of the County of São Paulo as the legal venue in which any legal collection action shall be filed in relation to this liability commitment.
